This Letter of Transmittal (the "**Letter of Transmittal**") is for use by registered holders ("**Chinook Shareholders**") of common shares ("**Chinook Shares**") of Chinook Energy Inc. ("**Chinook**") in connection with the proposed plan of arrangement pursuant to Section 193 of the *Business Corporations Act* (Alberta) (the "**Arrangement**") involving Chinook and the Chinook Shareholders pursuant to a plan of arrangement, the full text of which is set out in the Information Circular and Proxy Statement ("**Information Circular**") of Chinook dated November 14, 2016. Chinook Shareholders will not receive new class "A" common shares ("**New Chinook Shares**") in the capital of Chinook or their entitlement to an aggregate of 152,251,953 common shares ("**Craft Shares**") in the capital of 1947577 Alberta Ltd. (to be renamed Craft Oil Ltd.) ("**Craft**") currently held by Chinook until they submit their certificates for Chinook Shares to the Depositary along with a duly completed Letter of Transmittal. **Capitalized terms used but not defined in this Letter of Transmittal shall have the meanings given to them in the Information Circular.**

The undersigned delivers to you the enclosed certificate(s) representing Chinook Shares to be exchanged for certificates representing New Chinook Shares and Craft Shares pursuant to and in accordance with the Arrangement described in the Information Circular. Chinook Shareholders will receive one (1) New Chinook Share and 0.70343 of a Craft Share for each Chinook Share held on the effective date of the Arrangement, subject to adjustment to the entitlement to the number of Craft Shares (or fraction thereof) as a result of the issuance of additional Chinook Shares prior to the Effective Time.

3. represents and warrants that the undersigned has full power and authority to execute and deliver this letter of transmittal and that the information provided herein is true, accurate and complete as of the date hereof;
4. represents and warrants that it is a resident in the jurisdiction set out in "*Address of Chinook Shareholder*" on page 5 of this Letter of Transmittal;
5. acknowledges that if the Arrangement is approved at the Meeting, including any adjournment thereof, unless the Arrangement is not subsequently completed, the deposit of Chinook Shares pursuant to this Letter of Transmittal is irrevocable;
6. directs the Depository to issue or cause to be issued as soon as reasonably practical following completion of the Arrangement, the New Chinook Shares and Craft Shares to which the undersigned is entitled on completion of the Arrangement in the name indicated below, and to send the New Chinook Shares and Craft Shares to the address, or hold the same for pickup, as indicated in the Letter of Transmittal;
7. covenants and agrees to execute, upon request, any additional documents, transfers and other assurances as may be necessary or desirable to complete the exchange of certificate(s) representing Chinook Shares for certificate(s) representing New Chinook Shares and Craft Shares;
8. acknowledges that all authority conferred or agreed to be conferred by the undersigned herein may be exercised during any subsequent legal incapacity of the undersigned and shall survive the death or incapacity, bankruptcy or insolvency of the undersigned and all obligations of the undersigned herein shall be binding upon the heirs, personal representatives, successors and assigns of the undersigned;
9. by virtue of execution of this Letter of Transmittal, shall be deemed to have agreed that all questions as to the validity, form, eligibility (including timely receipt) and acceptance of any Chinook Shares deposited pursuant to the Arrangement will be determined by Chinook in its sole discretion and that such determination shall be final and binding and acknowledges there shall be no duty or obligation on Chinook, the Depository or any other person to give notice of any defect or irregularity and no liability shall be incurred by any of them for failure to give such notice; and
10. acknowledges that Chinook, the Depository and/or Craft may be required to disclose certain personal information in respect of the undersigned. The personal information of the undersigned may be disclosed by Chinook, the Depository and/or Craft to, and may be used by: (i) stock exchanges or security regulatory authorities; (ii) Chinook, the Depository and/or Craft; and (iii) any other parties involved in the Arrangement.

Unless otherwise indicated under "Special Registration Instructions" or "Special Delivery Instructions" below (in which case registration or delivery should be made in accordance with those instructions), the certificates for New Chinook Shares and Craft Shares should be issued in the name of the undersigned and forwarded to the undersigned at the address specified below the signature of the undersigned (or if no such address or delivery

instructions are made, to the latest address of record on Chinook's share register). If the Arrangement is not completed and the Plan of Arrangement is terminated, the undersigned directs the Depositary to return the enclosed certificate(s) to the address specified in accordance with the instructions in the preceding sentence.

Non-registered holders of Chinook Shares should contact their nominee (i.e. broker, trust company, bank or other registered holder) which holds their Chinook Share certificates on their behalf to arrange for their exchange.

If applicable, Chinook shall, or shall direct the Depositary to, make all withholdings from the consideration payable to holders of Chinook Shares required under applicable laws, including the *Income Tax Act* (Canada) and all applicable provincial and foreign legislation, and including in accordance with the terms and conditions set forth in the Plan of Arrangement.

INSTRUCTIONS

1. Fractional Interests

No certificates representing fractional Craft Shares or New Chinook Shares will be issued. In the event that a Chinook Shareholder would otherwise be entitled to a fraction of a Craft Share under the Arrangement, the number of Craft Shares deliverable to such Chinook Shareholder shall, without any additional compensation, be rounded down to the next lesser whole number of Craft Shares. In calculating such fractional interests, all Chinook Shares registered in the name of or beneficially held by such Chinook Shareholder or their nominee shall be aggregated.

2. Use of Letter of Transmittal

- (a) This Letter of Transmittal (or a manually executed facsimile copy hereof) validly completed and duly executed as required by the instructions set forth below, together with accompanying certificates representing the Chinook Shares and all other documents required by the terms of the Arrangement and this Letter of Transmittal must be received by the Depository at any of its offices specified on the back page of this document.
- (b) The method used to deliver this Letter of Transmittal and any accompanying certificates representing Chinook Shares and all other required documents is at the option and risk of the person depositing the same, and delivery will be deemed effective only when such documents are actually received by the Depository. It is recommended that the necessary documentation be hand delivered to the Depository at one of its offices specified on the back page of this document, and a receipt be obtained. However, if such documents are mailed, it is recommended that registered mail be used and that proper insurance be obtained. **Chinook Shareholders whose Chinook Shares are registered in the name of a nominee should contact their stockbroker, investment dealer, bank, trust company or other nominee for assistance in depositing those Chinook Shares.**

3. Special Registration and Delivery Instructions.

The boxes entitled "Special Registration Instructions" and "Special Delivery Instructions", as applicable, should be completed if the certificates for the New Chinook Shares and Craft Shares to be issued pursuant to the Arrangement are to be: (a) issued in the name of a person other than the person signing this Letter of Transmittal; (b) sent to someone other than the person signing the Letter of Transmittal; or (c) sent to the person signing the Letter of Transmittal at an address other than that appearing on the register of the Chinook Shareholders maintained by the transfer agent of Chinook. See also Instruction 5 below.

4. Signatures.

This Letter of Transmittal must be completed and signed by the holder of Chinook Shares (or by such holder's duly authorized representative in accordance with paragraph 6 below).

- (a) If this Letter of Transmittal is signed by the registered owner(s) of the accompanying certificate(s), such signature(s) on this Letter of Transmittal must correspond with the name(s) as registered or as written on the face of such certificate(s) without any change whatsoever, and the certificate(s) need not be endorsed. If such transmitted certificate(s) are owned of record by two or more joint owners, all such owners must sign this Letter of Transmittal.
- (b) If this Letter of Transmittal is signed by a person other than the registered owner(s) of the Chinook Shares or if New Chinook Shares and Craft Shares are to be issued to a person other than the registered holder(s):
 - (i) such deposited certificate(s) must be endorsed or be accompanied by an appropriate share transfer power of attorney duly and properly completed by the registered owner(s); and

- (ii) the signature(s) on such endorsement or power of attorney must correspond exactly to the name(s) of the registered owner(s) as registered or as appearing on the certificate(s) and must be guaranteed as noted in paragraph 5 below.

5. **Guarantee of Signatures.** If this Letter of Transmittal is executed by a person other than the registered owner(s) of the Chinook Shares, or if the New Chinook Shares and Craft Shares are to be issued to a person other than the registered holder(s) or are to be sent to an address other than the address of the registered holder(s) as shown on the register of Chinook Shares maintained by the transfer agent of Chinook, such signature must be guaranteed by an Eligible Institution, or in some other manner satisfactory to the Depository (except that no guarantee is required if the signature is that of an Eligible Institution).

An "**Eligible Institution**" means a Canadian Schedule 1 chartered bank, a member of the Securities Transfer Agent Medallion Program (STAMP), a member of the Stock Exchange Medallion Program (SEMP) or a member of the New York Stock Exchange Inc Medallion Signature Program (MSP) (members of these programs are usually members of a recognized stock exchange in Canada and the United States, members of the Investment Industry Regulatory Organization of Canada, members of the National Association of Securities Dealers of banks and trust companies in the United States).

6. **Fiduciaries, Representatives and Authorizations.** Where this Letter of Transmittal or any certificate or share transfer or power of attorney is executed by a person as an executor, administrator, trustee, guardian, attorney-in-fact or agent or on behalf of a corporation, partnership or association or is executed by any other person acting in a fiduciary or representative capacity, this Letter of Transmittal must be accompanied by satisfactory evidence of the authority to act. Chinook and the Depository, at their discretion, may require additional evidence of authority or additional documentation.

7. **Miscellaneous.**

- (a) If the space on this Letter of Transmittal is insufficient to list all certificates for Chinook Shares, additional certificate numbers and number of Chinook Shares may be included on a separate signed list affixed to this Letter of Transmittal.
- (b) If Chinook Shares are registered in different forms (e.g. "John Doe" and "J. Doe"), a separate Letter of Transmittal should be signed for each different registration.
- (c) No alternative, conditional or contingent deposits will be accepted. All depositing shareholders by execution of this Letter of Transmittal (or a copy thereof) waive any right to receive any notice by the Depository.
- (d) The holder of the Chinook Shares covered by this Letter of Transmittal hereby unconditionally and irrevocably attorns to the non-exclusive jurisdiction of the courts of the Province of Alberta and the courts of appeal therefrom.
- (e) Additional copies of the Letter of Transmittal may be obtained on request and without charge from the Depository at any of its offices at the addresses listed on the back page of this document.

8. **Lost or Destroyed Certificates.** If a share certificate has been lost or destroyed, this Letter of Transmittal should be completed as fully as possible and forwarded, together with a letter describing the loss, to the Depository. The Depository will respond with the replacement requirements, which must be properly completed and returned prior to the Depository issuing the consideration to which such Chinook Shareholder is entitled to receive under the Arrangement. If a share certificate has been lost or destroyed, please ensure that you provide your telephone number to the Depository and Chinook so that they may contact you.
